# **CONDITION OF ENTRY**

# [Birthday Bonus] - November, 2024 - All Tiers (Excluding Member)

**Promoter:** Breakwater Island Limited, as responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

#### 1. Promotional Period and Location

1.1. The Birthday Bonus promotion ("**Promotion**") commences at 09:00 on Friday 1 November, 2024 and ends at 23:59 Saturday 30 November, 2024 ("**Promotional Period**").

# 2. Eligibility to Enter

- 2.1. In order to participate in the Promotion, a person must:
  - a) be 18 years of age or over;
  - b) be a current Preferred, Executive, Director, President, Platinum, Chairman, Diamond, Magnetic VIP or Orpheus VIP member of Vantage Rewards program operated by the Promoter and have a current membership card (with selective criteria chosen by the promotor) (each a "Membership Card");
  - c) have a birthday that falls within the month of November;
  - d) not be the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);

### 7. Identification
