CONDITIONS OF ENTRY

[Dino Dollars] – Mondays in September, 2024 – All tiers (excluding Magnetic VIP and Orpheus VIP)

1. Promotional Period and Location

- 1.1. The **[Dino Dollars]** promotion ("**Promotion**") will commence at 16:00 on Monday 2 September, 2024 and concludes once the final prize draw has been conducted at 21:00 on Monday 30 September, 2024 ("**Promotion Period**").

5. Conduct of Prize Draws
