CONDITIONS OF ENTRY

1. Promotional Period and Location

- 1.1. The **[Lovers' Luck]** promotion ("**Promotion**") will commence at 18:00 on Monday 3 February, 2025 and concludes once the final prize draw has been conducted at 21:00 on Monday 24 February, 2025 ("**Promotion Period**").

2. Eligibility to Enter

- 4.2. Winners will receive their Prize after their identity has been confirmed in accordance with conditions under item **6. Identification**.

5. Conduct of Prize Draws
