CONDITIONS OF ENTRY

[Magic Mondays] - Mondays in January, 2025 (not valid Monday 27 January) - All tiers (excluding Magnetic VIP and Orpheus VIP)

1. Promotional Period and Location

- 1.1. The [Magic Mondays] promotion ("Promotion") will commence at 18:00 on Monday 6 January, 2025 and concludes once the final prize draw has been conducted at 21:00 on Monday 20 January, 2025 ("Promotion Period").
- 1.2. Prize draws will be conducted on the Main Gaming Floor at The Ville ("Draw Location").

2. Eligibility to Enter

5. Conduct of Prize Draws
