1. Promotional Period and Location

- 1.1. The **[Monster Mash Mondays]** promotion ("**Promotion**") will commence at 18:00 on Monday 14 October, 2024 and concludes once the final prize draw has been conducted at 21:00 on Monday 28 October, 2024 ("**Promotion Period**"). Promotion not valid Monday 7 October, 2024.
- 1.2. Prize draws will be conducted on the Main Gaming Floor at The Ville ("Draw Location").

2. Eligibility to Enter
