

## **CONDITIONS OF ENTRY**

### **[Monster Mash Mondays] – Mondays in October, 2024 – All tiers (excluding Magnetic VIP and Orpheus VIP)**

**Promoter:** Breakwater Island Limited, responsible entity for Breakwater Island Trust, ABN 48 071 515 194 trading as The Ville of Sir Leslie Thiess Drive, Townsville, Queensland, 4810.

#### **1. Promotional Period and Location**

- 1.1. The **[Monster Mash Mondays]** promotion (“**Promotion**”) will commence at 18:00 on Monday 14 October, 2024 and concludes once the final prize draw has been conducted at 21:00 on Monday 28 October, 2024 (“**Promotion Period**”). Promotion not valid Monday 7 October, 2024.
- 1.2. Prize draws will be conducted on the Main Gaming Floor at The Ville (“**Draw Location**”).

#### **2. Eligibility to Enter**

- 2.1. Participation in the Promotion is open to all persons who:
  - a) are 18 years of age or older;
  - b) be a current Member, Preferred, Executive, Director, President, Platinum, Chairman or Diamond member of Vantage Rewards program operated by the Promoter (with selective criteria chosen by the promotor) (each a “**Membership Level**”);
  - c) are entitled to access the draw location;
  - d) not be the subject of an exclusion direction or self-exclusion order pursuant to the Casino Control Act 1982 (Qld);
  - e) not be subject to restrictions on entering the property such as having been issued a Withdrawal of Licence; and
  - f) not be restricted from accumulating and redeeming any further benefits of their membership through having triggered a Pre – Commitment.

A person who meets the above criteria will be referred to as an “**Eligible Entrant**”.

- 2.2. The Promoter reserves the right to refuse any person participating in the Promotion at any time.

#### **3. Entry and Entry Periods**

- 3.1. An Eligible Entrant must present themselves at the Promotions Desk from 16:00 and 20:59 for each Promotion Period (“**Qualifying Period**”).
- 3.2. The Promotor will have representatives handing (1) entry (“**Entry**”) for the Draw Day using the membership records of those Eligible Members that are held by the Promoter.
- 3.3. Eligible Members must place their Entry in the barrel from 16:00 at the Draw Location up to one minute prior to each Prize Draw (each an “**Entry Period**”).
- 3.4. Entry forms are subject to audit for multiple entries by one (1) member. If any member is found to have submitted more entries than distributed, any winnings from that promotion will be forfeited.
- 3.5. Only one (1) Entry for the draw day will be issued to each Eligible Member for the Promotion and an Eligible Member is only entitled to enter the Promotion once for the Draw Day. Should an Eligible Member become a Winner, their Entry will not be re-entered into the barrel on that Draw Day. A Selected Member is only eligible to win one Prize Draw for the Draw Day of the Promotional Period.
- 3.6. Entries earned are valid for the Vantage Rewards membership level at the time of earning.

#### **4. Prizes**

- 4.1. The total prize pool for this Promotion is 1,750 Vantage Dollars each week.

- 4.2. Winners will receive their Prize after their identity has been confirmed in accordance with conditions under item **6. Identification**.
- 4.3. All Prizes must be taken as stated and cannot be exchanged for alternate prizes or offers. Any tax implication or liability that attaches to a Prize will be the sole responsibility of the relevant winner.

## **5. Conduct of Prize Draws**

- 5.1. The Promoter will conduct Prize Draws approximately every thirty minutes at 18:00, 18:30, 19:00, 19:30, 20:00, 20:30 and 21:00 (each a '**Prize Draw**').
- 5.2. The Drawn Entry must be verified by two (2) representatives of The Ville to ensure the correct name is announced.
- 5.3. The name (and membership number if relevant) of the Eligible Entrants identified on the Drawn Entry will be announced at the Draw Location ("**Drawn Entrant**"). The Promoter cannot guarantee that announcements can be heard in all parts of the Draw Location or throughout the remainder of the venue during the Prize Draw announcements.
- 5.4. The Promoter reserves the right to announce the name of Selected Members at other locations throughout The Ville.
- 5.5. Selected Members must be "**present at the relevant Prize Draw**" in accordance with **Condition 5.6** to be eligible to win. If a Selected Member is not "present at the Prize Draw", **Condition 5.7** will apply and that Entry will be returned to the barrel to be eligible for the remaining Prize Draws on that Draw Day.
- 5.6. To be deemed "**present at the Prize Draw**" the Drawn Entrant must present themselves to a representative of the promoter at the Draw Location or the Orpheus Room Concierge Desk at The Ville within two (2) minutes of their name being announced and provide suitable identification in accordance with conditions under item **6. Identification** ("**Winner**"). Drawn Entrants are not permitted to send a proxy to claim a prize.
- 5.7. If a Selected Member does not satisfy **Condition 5.6** or does not otherwise satisfy these Conditions of Entry, redraws will take place until a Selected Member who satisfies the requirements of these Conditions of Entry (including by being "present at the Prize Draw") is drawn for each of the relevant Prize Draws.

## **6. Identification**

- 6.1. A Selected Member must produce valid acceptable identification to a representative of the Promoter to confirm their eligibility to win a prize. Valid identification acceptable to the Promoter will be either one form of valid photographic identification (Passport or Australian driver's license) with an

undamaged clearly visible photograph, or two other forms of non-photographic identification acceptable to the Promoter.

- 6.2. The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a Selected Member is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

## **7. Invalid Draws/Entries**

- 7.1. If an entry is gained by means other than in accordance with these Terms and Conditions, the entry will be deemed invalid.
- 7.2. Should the casino operator determine that the integrity of the promotion and/or draw has been compromised it may either postpone the promotion and/or draw until such a time as the integrity of the promotion and/or draw has been validated or cancel the draw.

## **8. General**

- 8.1. Directors, management and employees of The Ville or any suppliers or agencies associated with this Promotion are not eligible to participate in this Promotion.
- 8.2. The Promoter is not responsible for any loss, damage or injury suffered or claimed (including, but not limited to, indirect or consequential loss or damage, personal injury or death, and direct or indirect loss or damage due to negligence or technical or mechanical malfunction) by an entrant in relation to entering or participating in this Promotion or taking or using the prizes offered (except that which cannot be excluded by law) except where that loss, damage or injury was caused by breach of these terms and conditions by the Promoter or the willful or negligent acts or omissions of the Promoter. To avoid any doubt, the Promoter shall not be liable for loss caused by technical and mechanical malfunction which is outside the control of the Promoter.
- 8.3. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
- 8.4. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these terms and conditions in its sole and absolute discretion.
- 8.5. While the Promoter intends to conduct the Promotion as offered, the Promoter reserves the right to cancel or change the Promotion or a prize offered in the Promotion if it can no longer continue the Promotion or offer a prize due to circumstances outside the Promoter's control.
- 8.6. The Promoter accepts no responsibility for late or non-received entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion. In the event of any technical difficulties with the kiosk, the Promoter reserves the right to adopt a manual process of generating entries.
- 8.7. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
- 8.8. Drawn entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant selected member. The names of drawn entrants will not be published without their consent except as announced at the Draw Location.
- 8.9. Participation in the Promotion indicates acceptance of the terms and conditions governing the Promotion. These terms and conditions will be available at the Vantage Rewards Customer Service Desk at The Ville throughout the Promotion Period.
- 8.10. By participating in this Promotion, each entrant's entry/entries becomes the property of the Promoter and may be used for the Promoter's business analysis and marketing purposes in accordance with the Promoter's privacy statement which can be viewed at [the-ville.com.au](http://the-ville.com.au). Privacy law allows entrants to access their personal information held by the Promoter in certain circumstances. Failure to supply the personal information requested may result in an entry being deemed invalid.
