1. Promotional Period and Location

- 1.1. The **[Snowy Mondays]** promotion ("**Promotion**") will commence at 18:00 on Monday 2 December, 2024 and concludes once the final prize draw has been conducted at 21:00 on Monday 30 December, 2024 ("**Promotion Period**").

- 4.2. Winners will receive their Prize after their identity has been confirmed in accordance with conditions under item **6. Identification**.

5. Conduct of Prize Draws
